



## **OAK SCURRO**

The dark brown hues in this smoked, single-strip oak floor from the Domani Collection highlight its rustic expression. Knots and cracks pepper the boards, resulting in a beautifully aged effect reminiscent of reclaimed timber. Four-sided micro-bevelling at the edges ensures a classic full plank look and feel. Hand-scraping enhances the worn appearance of the floor.
