The white oiled surface of this smoked, 2-strip floor from the Da Capo Collection brings out the rustic characteristics in the timber. This beautifully aged effect is prominent and provides a balanced contrast to the lighter finish. Each board is carefully brushed to bring out the character of the grain and highlight the natural texture of the wood. Four-sided bevelling ensures a classic, full plank look and feel. Each board is meticulously hand-scraped, which enhances the worn appearance of the floor.
