The pale, sandy-brown hues in this single-strip, oak floor from the Prime Collection balances the subtle colour variation in the timber. The matt lacquer finish eliminates glare while protecting the wood from daily wear. Four-sided micro-bevelling at the edges ensures a classic, full plank look and feel.
