



OAK FOSSIL

This single-strip oak floor from the Rugged Collection has been lightly smoked to create an authentically aged look. Rustic knots and cracks mottle the golden-grey planks and the stain brings a milky hue. Each board is carefully brushed to bring out the character of the grain and highlight the natural texture of the wood. Four-sided bevelling at the edges ensures a classic, full plank look and feel. Hand-scraping enhances the worn appearance of the floor.
