



## OAK HEATHER MATTE

This plank oak floor from the Canvas Collection features a warm gray stain with soft white graining and neutral undertones. With subtle variation and some knots to provide dimension, the result is a fresh, eye-catching version of the popular gray floor. Each board is carefully brushed to bring out the character of the grain and highlight the natural texture of the wood. The matt lacquer eliminates glare while protecting the wood from daily wear. Four-sided micro-bevelling at the edges ensures a classic full plank look and feel.
