



## OAK BISCUIT

The dusty blonde hues in this single-strip oak floor from the Living Collection enhance the natural rays present in the timber for a distinctive expression. Each board is carefully brushed to bring out the character of the grain and highlight the texture of the wood. Four-sided micro-bevelling at the edges ensures a classic full plank look and feel. The matt lacquer finish eliminates glare while protecting the wood from daily wear.
