



ASH VERVE

This 3-strip, stained ash floor from the Lumen Collection features earthy undertones and soft, stone grey hues. Each board is carefully brushed to bring out the character of the grain and highlight the natural texture of the timber. The ultra-matt lacquer finish enhances the natural variations in the wood, creating the impression of newly sawn timber. This effectively eliminates glare while protecting the floor from daily wear.
