Naturally occurring wood color variations allowed, ranging from light to dark brown tones. Sapwood will be present. The product features large knots, as well as occasional natural cracks. Knot holes and cracks are repaired with dark filler.

Ultra matt lacquer: The appearance of the matte surface may vary due to different light sources and angles.

Colour change: Stained product - noticeable color change over time.

Packages may contain start and stop boards.

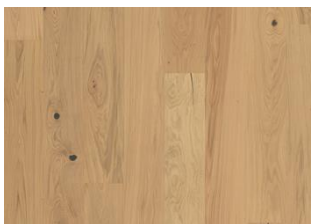
