The inky black pigments found in this 2-strip oak floor from the Classic Nouveau Collection beautifully accentuate the bitter chocolate undertones, resulting in a sophisticated and versatile expression. Each board is carefully brushed to bring out the character of the grain and highlight the natural texture of the wood. Four-sided bevelling at the edges ensures a classic full plank look and feel. The matt lacquer finish eliminates glare while protecting the wood from daily wear.
